## Decorated Green Beret threatened with court martial for blowing whistle on 'dysfunctional' hostage recovery effort

Lt. Col. Jason Amerine, a decorated Green Beret who was among the first on the ground in Afghanistan after 9/11, is now under investigation by the U.S. Army and was threatened with court martial for sharing information with lawmakers about what he calls a "dysfunctional bureaucracy" preventing the recovery of American hostages held by Islamist terrorists.

"Warren Weinstein is dead. Colin Rutherford, Joshua Boyle, Caitlin Coleman and the child she bore in captivity remain hostages in Pakistan. I used every resource available but I failed them," Amerine told a Senate committee during a hearing on whistleblower protection Thursday, listing the names of American hostages.

"One of those resources was my constitutional right to speak to members of Congress." But he testified that "after I made protected disclosures to Congress, the Army suspended my clearance, removed me from my job, and sought to court martial me."

Amerine told lawmakers he is now being punished by the Army for speaking to members of Congress about his concerns over an incoherent U.S. hostage policy.

He said he reached out first to Rep. Duncan Hunter, R-Calif., because of his position on the House Armed Services Committee and because he wanted to repair a "broken" hostage recovery system.

"Here is someone who is trying to save lives and who puts it on his sleeve basically what he is doing and he got slammed for it by the Army," Hunter said in an interview with Fox News.

"So you have them doing a retaliatory investigation of a great soldier. This is the kind of guy we want in the Army. This is who we want out there fighting for us," Hunter said of Amerine, who received the Bronze Star with Valor for his actions in Afghanistan.

Hunter showed his support for Amerine Thursday by sitting behind the decorated soldier during the hearing on Capitol Hill as Amerine testified along with other whistleblowers who also had faced retaliation.

Five years ago, Amerine was tasked by Gen. John Campbell, currently the top U.S. commander in Afghanistan, to find ways to bring home Taliban prisoner U.S. Army Sgt. Bowe Bergdahl after Army commanders realized there was no coherent plan to do so.

While working to free Bergdahl, Amerine realized there were other American hostages being held by Al Qaeda and Pakistan as well, but with all eyes on Bergdahl, the civilian hostages were forgotten and there was no plan to rescue them, he said.

Amerine believed a one to seven trade-off of the "Afghan Pablo Escobar," Haji Bashir Noorzai, currently serving a life sentence in the United States, for all the Americans was possible.

Instead, Bergdahl was traded for five senior Taliban leaders who had been serving indefinite sentences at the U.S. military's prison in Guantanamo Bay, Cuba -- a deal he said had been rejected by senior U.S. officials years ago.

"My team had a difficult mission and I used all legal means available to recover the hostages. You, the Congress, were my last resort," he told lawmakers. "I am before you because I did my duty and you need to ensure all in uniform can go on doing their duty without fear of reprisal."

He said he is being retaliated against because the FBI and others were angry when Hunter revealed the Defense Department had tried to pay a ransom for Bergdahl, which is against U.S. law.

Amerine said he drew their ire when Hunter submitted a complaint to the Inspector General alleging an "illegal or questionable" ransom had been potentially paid in a failed attempt to free Bergdahl.

"There was a good deal of evidence that it occurred and a lot of questions as to how it occurred," Amerine told Senator Ron Johnson, R-Wisc, chairman of the Senate Homeland Security and Government Affairs Committee.

Amerine accused the State Department, FBI and CIA of not sharing information with the military and described turf battles and bureaucratic "stove pipes" that he said have hindered the return of American hostages such as Caitlin Coleman, who recently gave birth in captivity in Pakistan, and Warren Weinstein, who was killed in a CIA

drone strike in January.

The Army denied there was any retaliation against the decorated Special Forces officer.

"As a matter of policy, we do not confirm the names of individuals who may or may not be under investigation to protect the integrity of a possible ongoing investigation, as well as the privacy rights of all involved. However, I note that both the law and Army policy would prohibit initiating an investigation based solely on a Soldier's protected communications with Congress," a spokeswoman for the U.S. Army said in a statement.

The FBI declined comment when contacted by Fox News.

Meanwhile, the Army has cancelled Amerine's planned retirement this summer.

#### **Dying Veteran Exposes Veterans Choice Card Problems**

KARE 11 investigative reporter AJ Lagoe helped dying veteran Paul Walker expose Veterans Choice Card program problems, problems that provide many veterans with no choice at all. Coverage aired on Minneapolis' NBC last night, and what reporter AJ Lagoe uncovered will shock many Americans.

Disabled veteran Paul Walker just came face to face with that brutal reality of no choice after learning he was dying of state 4 liver cancer. VA failed to provide timely assessment of Walker's condition and went on to refuse life saving surgery after telling him he had 3-6 months to live. If limited to VA health care, Paul Walker will be dead in 3-6 months.

#### **KARE 11 VETERANS CHOICE INVESTIGATION BACKGROUND**

To give some background, I am Paul Walker's attorney and am helping him help other veterans fight for access to health care by exposing this farce of a program called Veterans Choice. I generally represent veterans related to health care problems including lack of access to non-VA health care nationwide. A big part of my practice relates to this issue and helping veterans access non-VA health care even through non-VA channels such as through state funded programs.

In my presence at Minneapolis VA, Walker called Veterans Choice to see what options he may have for non-VA care. Previous to the call, I escorted Walker through Minneapolis VA to observe how VA staff treated him in person because of concerns he expressed about VA staff being adversarial toward him. Overall, most staff members that day were initially adversarial but later backed off once Walker explained he was dying of stage 4 cancer.

I find that veteran treatment is sometimes dependent on the kinds of clothes the veteran is wearing and grooming. That day, Walker looked similar to how he looked in the KARE 11 video linked above.

On the phone with a VA operator, Walker explained his situation and why he wanted Veterans Choice, i.e. non-VA care. Unfortunately, he was denied at the time despite living more than 40 miles from his primary care center.

Instead, the VA operator informed Walker that since he lived 16 miles from a VA dental clinic, that he was not eligible for non-VA care for his liver cancer. When Walker asked for a letter documenting his denial, VA refused to provide written documentation.

Walker immediately reached out to KARE 11 News to investigate. Investigative reporter AJ Lagoe was quick to contact Walker and me. He offered to help us expose the very real lack of choice Walker faced in getting treatment for his deadly cancer.

Nationally, VA has recently claimed veterans refuse to use the Veterans Choice program because they love VA health care versus non-VA health care. Their argument continues that since so few veterans choose to use the program that the funds should be diverted to other parts of VA.

This claim is most certainly a public relations spin on reality to manipulate the public into believing veterans only want VA health care. Do you think most veterans truly want only VA health care?

#### **RELATED: VA plots to gut Veterans Choice Program**

A couple weeks after we contacted the press and with KARE 11 in the room, Walker again contacted Veterans Choice with a slightly different scenario. By that time, his condition was fully diagnosed, VA prescribed him heavy painkillers that prevented him from driving, and he was informed of his death sentence of 3-6 months to live. Still, VA refused to allow him to seek non-VA care in his community despite his inability to drive and being near death.

Walker wanted to show KARE 11 what happened when he tried using the Choice Card Veterans Affairs sent him, so he called the number on his card while Investigative Reporter A.J. Lagoe watched. "I want to see about getting preauthorization to get cancer treatment at a facility closer to me," Walker told the operator. But he was told he was not eligible under the 40 mile rule because the Northwest Metro VA Clinic in Ramsey is only 20 miles from his home. The frustrated veteran told the woman handling his Choice Card call that the Ramsey clinic does not offer the cancer treatment he needs. "All they do is dental work there and eye work and some basic kinds of different minor things," he told her. "But I have cancer stage 4." Paul's reasoning that the clinic near him doesn't offer the treatment he needs got him nowhere. "I don't get a choice. I get to die. So, to me that's not a choice," he said.

KARE 11 News inquired about veterans' stories across the country, and I had the displeasure of explaining that Paul Walker was not alone in being refused Veterans Choice.

"I've been hearing this across the country," said Benjamin Krause, a disabled vet and Twin Cities-based attorney focusing on veterans' issues. Krause is representing Paul Walker and had harsh words for the choice program.

"The supposed VA choice is nothing more than a bill of goods that they sold us," he said.

Krause points to the fact the VA is now claiming that since so few veterans are using the Choice Card program, the billions of dollars sitting there to fund Veterans Choice could be better spent.

"Now they're trying to justify the fact veterans are not using this choice, which is really no choice at all, as a means to defund the program and move the money elsewhere," said Krause.

Reporter AJ Lagoe requested feedback from VA through a FOIA to see how many veterans have been allowed to use Veterans Choice and how many veterans have been turned down. It may come as no surprise that VA does not count veterans turned down for the program using incredibly squirrely logic:

"No veteran is turned down. They either meet the criteria which is >40 miles from a VA facility or >30 days for an appointment, or they do not."

#### **Veterans Alternative Therapy Center Plans Grand Opening**

HOLIDAY — With help from U.S. Rep. Gus Bilirakis and other leaders, Veterans Alternative Therapy Center will mark its grand opening on Memorial Day.

The festivities will take place 5-7 p.m. Monday, May 25, at the center, 1750 Arcadia Road.

"It's been an incredible transformation and now it's time to celebrate," Veterans Alternative owners Brian Anderson and Janel Norton wrote in a flyer.

Demonstrations will show off the center's confidence course, FCS kali martial art, yoga and more. Glory Days Grill is donating food. The pool will be open.

The firm aims to transform post-traumatic stress into post-traumatic growth by offering research-proven, alternative therapies such as Accelerated Resolution Therapy, Integrative Resolution and camaraderie-building programs.

"It is a fantastic project and the Congressman is a strong supporter of the work being done there," Ian Martorana, communications director for Biliarkis, wrote in an email.

Biliarkis, R-Palm Harbor is the sponsor of the proposed Creating Options for Veterans Expedited Recovery Act, which passed a subcommittee last week and was due for a committee vote this week. Martorana predicts the legislation could soon go to the U.S. House floor for a final vote.

Bilirakis is vice chairman of the House Committee on Veterans Affairs.

The COVER Act would set up a commission to explore options and recommend any funding.

"The Congressman believes that one size does not fit all, especially when it comes to an issue as sensitive as the mental health needs of our veterans," Martorana said. "He wants to make sure that all Veterans have access to the treatments they need in order to successfully transition into civilian life.

"While this bill doesn't allot a specific amount of money for these treatments, it represents significant progress in changing the way the mental health needs of our veterans are handled. It is definitely a step in the right direction in addressing the serious gaps that exist in caring for the invisible wounds of our nation's heroes."





### **Eight Remaining Female Candidates Fail First Phase of Ranger School**

The remaining eight female Ranger School candidates failed the first phase of the U.S. Army's elite infantry program, the Army said in a statement late Friday.

Of the eight women, five were kicked out of training. Three others will be allowed to start over from the beginning of the first phase of Ranger School. Those three will start class on June 21.

The Army said in a statement that 29 students failed to meet the standards of phase one, also known as the Darby Phase. A vast majority of the students who are being dropped from the course were unable to successfully lead a patrol. All students received multiple opportunities to lead a patrol as a squad or team leader, the Army said.

"Each Ranger student, whether successful or unsuccessful, learned more about themselves, leadership and small unit tactics, and returns to the Army a better trained Soldier and leader," said Colonel David G. Fivecoat, Commander of the Airborne and Ranger Training Brigade.

This was the first time women were allowed to participate in Ranger School.

The Darby Phase is followed by a mountain phase which is then followed by a swamp or Florida phase. The next phase of Ranger School will start June 25.

A total of 60 women were originally slated to participate in Ranger Assessment Phase (RAP), according to the Pentagon in January. The Army Times reported in February that 100 women went into the pre-training phase, and in April, 19 women qualified for the Darby Phase.

The training for Ranger School is notoriously difficult. The Darby Phase consists of 15 days of intensive squad training and operations in field environment at Fort Benning, Georgia. The students get at least two days where they are counseled on their performance during the phase.

"The key is to ensure we have the right standard for the occupation," a defense official told Fox News earlier this month. "Our goal is to ensure that the mission is carried out by the best qualified and the most capable service members, regardless of gender."

The Rangers also note that 33 percent of the soldiers who graduate Ranger School are typically "recycled," meaning they have failed the course at least once before.

The Pentagon lifted its ban on women in combat in 2012 and while they would not have been able to become full members of the Rangers, this would have given them their first foray into all-male Special Operations. Typically attached to combat units, at least 130 women were killed and 800 wounded in the Iraq and Afghanistan wars. Many were "non-combat" in name only and involved in front line operations all the same.

Peer evaluations are held periodically in Ranger School, but a defense official could not confirm if those evaluations contributed to the women not completing the first phase of training.

According to statistics, only 3 percent of the U.S. Army is Ranger-qualified. Fox News' Lucas Tomlinson contributed to this report

#### **Obtaining Veteran Service Documents**

#### By U.S. Army Human Resources Command - April 20, 2012

FORT KNOX, Ky. -- Army veterans who served on active duty or in the Army Reserve, and the family members of those veterans, are eligible to receive service-related documents for free through a number of official sources.

Soldiers who separated in October 2002 or later can submit a signed Standard Form 180/ Request Pertaining to Military Records (www.archives.gov/research/order/standard-form-180.pdf) to the U.S. Army Human Resources Command using one of the following methods: a signed request can be scanned and emailed to askhrc.army@us.army.mil, or mailed to:

> U.S. Army Human Resources Command ATTN: AHRC-PDR-V/ Department 420 1600 Spearhead Division Ave. Fort Knox, KY 40122-5402.

Soldiers who separated prior to October 2002 should submit a signed SF 180 to the National Archives and Records Administration's National Personnel Records Center at:

> National Personnel Records Center 1 Archives Drive St. Louis, MO 63132-1002 or call the NPRC at 314-801-0800.

National Guard Soldiers are encouraged to contact their State Adjutant General. Contact information for each State National Guard Agency can be found at http://www.nationalguard.mil/resources/ states.aspx.

Veterans can also access their information directly through a joint partnership between the Department of Veterans Affairs and the Department of Defense known as eBenefits. For more information about eBenefits, visit http://www.ebenefits.va.gov.

The Army Human Resources Command also provides veterans with services such as creating DD Form 215s, updating retirement points for Reserve Component Soldiers, verifying veterans' service for VA home loans, and providing statements of service for veterans employment verification. You can contact HRC directly by calling 1-888-ARMYHRC (276-9472).

Many "for profit" third-party commercial businesses are charging for the services described above, often advertising that they can expedite processing or delivery times for documents. These claims are false, because no increased levels of service or access to veteran records are provided to these commercial entities. By requesting these documents directly through the government agencies listed, you can eliminate the middle man, saving yourself time and money.
